OPINION ON DECISION

INJURY AOE COE

On 11/12/2015 the applicant filed a claim of injury to his brain (headaches), chest, right hip and low back occurring between 07/15/2015 and 10/25/2015 while employed as a barber from experiencing what he claimed to be verbal abuse at work. The claim was denied.

On 11/21/2016 applicant then amended to the date of injury to 07/15/2015 claiming he was attacked by a coworker.

On 05/17/2017, the date of trial, applicant again amended his claim to an undetermined specific date of injury between 07/15/2015 and 08/07/2015, contending he sustained injury to his brain, in the form of headaches, psychiatric, hip and low back.

Multiple witnesses, former coworkers and supervisors testified giving evidence contrary to the testimony of the applicant whom the undersigned did not find to be a credible witness on his own behalf. Every point or statement the applicant made in his claim was met with credible and specific rebuttal testimony by the defense witnesses: Kimberly Horst, Erica Hartley, Natalie Galvez and

Mark Morgan, who the court all found to be very credible. Therefore, it is found that applicant DID

NOT sustained any injury arising out of and occurring in the course of employment with Floyd's 99

Colorado LLC.

LABOR CODE §3600 (a) (10)

Labor Code §3600 (a) (10). Applicant's post termination reporting of a specific injury is barred. At

the termination interview the applicant failed to bring forth any complaints of any type of injury to

either Erica Hartley, district manager or Kim Horst, site manager. In the end this appears to be a

retaliatory claim.

LABOR CODE \$3208.3

Labor Code §3208.3(e). Applicant failed the threshold on his burden of proof. The applicant offered

no substantial evidence of psychiatric injury by any medical record or LC §4060 evaluation.

The applicant commenced employment at Floyds on 05/29/2015 and was terminated for cause on

10/21/2015, a period of 4 months and 23 days. There is no evidence that any exceptions to the 6-

month rule exist under LC §3208.3 (d). There is no evidence that applicant suffered any psychiatric

injury as a result of his employment at Floyd's 99 Colorado LLC.
