Notice of Intention to Impose Sanctions
Labor Code Section 5813
Title 8, California Code of Regulations,

The above entitled matter having been heard and regularly submitted, the Honorable Bonita A. Edelberg, Workers' Compensation Administrative Law Judge, now decides as follows:

FINDINGS OF FACT

- Jose Luis Reyes, born , while employed during the period from May
 1, 2011 through September 1, 2012 as a machine operator at Los Angeles, California by
 ACE Commercial, Inc., whose carrier at the time of the injury was preferred Employers
 Insurance Company, did not sustain injury which arose out of and in the course of employment to his trunk, legs, nervous, back, shoulders, hernia, neck, chest, varicose veins and sleep.
- Lien claimants, Kohanim Chiropractic, Inc., Marina Kuznetsova, L.Ac.,
 Metropolitan Health Medical, Rite Care Orthopedic Supply and Socal Interpreting, and

each of them, failed to carry the burden of proof on the issue of injury which arose out of and in the course of employment.

- 3. Lien claimants, and each of them failed to provide evidence of any relevancy or weight on the issue of injury which arose out of and in the course of employment.
- Lien claimants, and each of them, shall take nothing in this matter. All liens are disallowed.
- 5. There was no evidentiary basis for lien claimants to proceed to trial.

EVIDENTIARY RULING

Defendant's objection to Exhibit 3 is hereby overruled.

ORDER

IT IS HEREBY ORDERED THAT lien claimants, Kohanim Chiropractic, Inc., Marina Kuznetsova, L.Ac., Metropolitan Health Medical, Rite Care Orthopedic Supply and Socal Interpreting, take nothing on the liens filed herein. All liens are disallowed.

NOTICE OF INTENTION TO IMPOSE SANCTIONS

Lien claimants, represented by Patrick Petronella for GB and C provided no evidence which was relevant to or of probative value on the issue of injury which arose out of and in the course of employment and did not properly subpoena applicant for trial, all as set forth in detail in the Opinion on Decision.

Lien claimants, and each of them, and their representative knew or should have known that the evidence relied on at trial was utterly incapable of meeting the required burden of

ADJ8640617 Document ID: 3944530211260858368 proof on that issue and that insistence on trial without relevant and probative evidence results only in the needless waste of Court resources and time and in an increase in the cost of litigation incurred by defendant and is therefore frivolous and egregious warranting sanctions under Labor Code Section 5813 and Title 8, California Code of Regulations, 10561.

The activities undertaken by lien claimants and their representative were egregious and frivolous, warranting sanctions by this Court payable to the Workers Compensation Appeals Board and warranting payment of reasonable attorney fees and costs for the legal services rendered in defending against the activities of lien claimants and each of them, pending the filing and serving of a Bill of Particulars by Greenup, Turchin & Hartston,

NOTICE IS HEREBY GIVEN that an Order for sanctions shall issue for egregious conduct and bad faith tactics in the sum of:

\$2,500.00 payable joint and several by Kohanim Chiropractic, Inc. and GB and C and Patrick Petronella:

\$2,500.00 payable joint and several by Marina Kuznetsova, L.Ac., and GB and C and Patrick Petronella;

\$2,500.00 payable joint and several by Metropolitan Health Medical and GB and C and Patrick Petronella;

\$2,500.00 payable joint and several b, Rite Care Orthopedic Supply and GB and C and Patrick Petronella;

\$2,500.00 payable joint and several by Socal Interpreting and GB and C and Patrick Petronella payable to the Workers Compensation Appeals Board absent written

objection showing good cause to the contrary filed and served within twenty (20) days of service hereof.

FURTHER NOTICE IS HEREBY GIVEN that an Order for reasonable attorney fees and costs shall issue payable joint and several by lien claimants and GB and C and Patrick Petronella to Greenup, Turchin & Hartson on behalf of Preferred Employers Insurance Company within twenty (20) days of the filing and serving of defendant's Bill of Particulars, which is to be filed and served within fifteen (15) days of service hereof, absent objection in writing setting forth good cause to the contrary within twenty (20) days of service hereof.
